

# Instructions for Student Discipline at the Institutions of the Ministry of Higher Education and Scientific Research

## Article 1

The student is committed to the following:

**First:** compliance with laws, regulations, internal regulations, instructions and orders issued by the ministry of higher education and scientific research and its institutions (university, body, college, institute).

**Second:** Not to prejudice religious beliefs, national unity or national feelings, or to deliberately provoke sectarian, ethnic or religious strife by deed or word.

**Third:** Do not harm the reputation of the ministry or its institutions by deed or word inside or outside.

**Fourth:** Avoid all that is contrary to university behavior of high discipline and respect for management, faculty and staff, fellowship relations and cooperation with students.

**Fifth:** Disciplined and correct behavior that will have a positive impact on him when hiring and being nominated for missions and fellowships.

**Sixth:** Refrain from any act that would disturb the system, security and tranquility inside the campus (college or institute), participate, incite or cover up those involved in.

**Seventh:** Maintaining the educational supplies and property of the university, body, college or institute.

**Eighth:** Not to disturb the proper conduct of study in college or institute.

**Ninth:** Compliance with the uniform prescribed for students, subject to the specificity of each university or body.

**Tenth:** Avoid calling for organizations that would deepen discrimination or practice any kind of political, religious or social persecution.

**Eleventh:** Avoid advertising for any political party, organization or any ethnic, national or sectarian group, whether in hanging pictures, banners and posters or in holding seminars.

**Twelfth:** Not to invite party figures to deliver lectures or holding party or religious symposiums inside the campus in order to preserve the national unity.

## Article 2

The student shall be punished by alarm if he commits one of the following offences:

**First:** Non-compliance with the uniform prescribed by the university or body.

**Second:** Abuse to the relations of fellowship among students or bypass by word to any student.

## Article 3

The student shall be punished by warning if he commits one of the following offences:

**First:** Commit any action that requires punishment by alarm when being previously punished via the penalty of alarm.

**Second:** Violating the system, security and tranquillity of the university, body, college or institute.

## Article 4

The student shall be punished by insulation for 30 days if he commits one of the following offences:

**First:** Commit any action that requires punishment by warning when being previously punished via the penalty of warning.

**Second:** Bypass by word towards any one of the university's non-faculty members.

**Third:** Defame a faculty member in a way that would harm inside or outside the college or institute.

**Fourth:** Putting up posters inside the campus that disturbs public order and morals.

## Article 5

The student shall be punished by the penalty of temporary dismissal from the university for a period of not more than one academic year if he commits one of the following offences:

**First:** Repeat one of the acts stipulated in article (4) of these instructions.

**Second:** Exercise or incite sectarian or ethnic blocs, political or party gatherings inside the campus.

**Third:** Defame a non-faculty member of the university in deed.

**Fourth:** Use of violence against fellow students.

**Fifth:** Threat of armed violence.

**Sixth:** Carrying licensed or unlicensed weapons of all kinds inside the campus.

**Seventh:** Causing damage intentionally or in grossly negligence to the property of the university, body, college or institute.

**Eighth:** Abuse to the national unity or religious beliefs.

**Ninth:** Defame a faculty member inside or outside the college or institute.

**Tenth:** Harming the reputation of the university or the body by word or deed.

**Eleventh:** Intentional violation of the proper conduct of the study.

**Twelfth:** Proved to commit fraud against fellow students and members of the college or institute.

## Article 6

The student shall be punished by the penalty of final dismissal of the college or institute by a decision of the university or body if he commits one of the following offences:

**First:** Repeat one of the offences stipulated in article (5) of these instructions.

**Second:** Assault a faculty member or lecturer at the university, body, college or institute in deed.

**Third:** Acting a disgraceful deed that is contrary to public morals.

**Fourth:** Submitting any forged documents or books knowing that they were forged or incite forgery.

**Fifth:** Proved to commit, participate or assist in any act that violates security and tranquillity inside the campus.

**Sixth:** Being sentenced for a felony or misdemeanour in violation of honor for more than one year.

## Article 7

**First:** The imposition of the penalties stipulated in articles (2), (3), (4), (5) and (6) of these instructions on the offending student does not prevent the imposition of other penalties if the violation falls under the penalty of punitive laws.

**Second:** If a criminal case is brought against the student for an act attributed to him outside the university or institute, then it will be considered as a disciplinary delay until the criminal case is decided.

### Article 8

The dean of the faculty or institute shall form a student discipline committee headed by the associate dean and the membership of two faculty members, provided that one of the members is a legal member and a representative of the elected student union and one of the administrative staff is assigned to the work of the committee's rapporteur.

### Article 9

No disciplinary penalty may be imposed unless recommended by the Student Discipline Commission.

### Article 10

The disciplinary sanctions stipulated in these instructions are imposed by a decision of the College Council or Institute, and the Council may authorize its powers to the dean of the college or institute.

### Article 11

**First:** The penalty of warning and alarm is absolute.

**Second:** For a student who is dismissed from the college or institute for a period of not more than (30) thirty days the right to object to the decision of dismissal to the college council or the institute and the decision shall be definitive.

**Third:** For a student who has been dismissed from the college or institute for a period of not more than (30) thirty days the right to object to the decision of dismissal to the university rector and the decision shall be definitive.

**Fourth:** For a student who has been dismissed from the college or institute finally the right to object to the decision of dismissal to the university council and the decision shall be definitive.

### Article 12

The student has the right to object to the decisions of dismissal stipulated in the clauses (2), (3) and (4) of article (11) of these instructions within (7) seven days from the date of informing him of the decision issued against him and if he is not informed, he has the right to object within (15) fifteen days from the date of publication of the decision of dismissal on the billboard.

### **Article 13**

The penalty decision is hanged for at least (15) fifteen days on the billboard and the student's guardian shall be informed of.

### **Article 14**

The student discipline instructions of the higher education No. (19) of 1989 shall be abolished.
